Message from CEO Charles B. McKenna



The pages that follow this message tell a far better tale about SDA's progress than I ever could. As the chart on page seven illustrates, we presently have 12 projects in active construction all across the state. The Elliott Street School in Newark will welcome students in January 2016 as will the addition at the Buckshutem Road Elementary School in Bridgeton. Before the end of the current school year, it is also expected that the Oliver Street School in Newark will open for students. In September 2016, we will open five new schools including high schools in Phillipsburg and Elizabeth. As these schools open, the SDA will begin construction of schools that are already on the drawing board. In short, the SDA is fulfilling the mission of this Administration to build schools effectively, efficiently, on-time and on-budget. A few of the schools opening between now and next September were

schools that had been on the boards for ten or more years and were never built -- now they are a reality.

This past September, the Passaic Gifted and Talented Academy welcomed 785 students to its sparkling corridors. Across the street, the process of constructing another school has started. Once the Leonard Place School is complete, we will begin work on the Dayton Avenue project. This will be a large school, that when completed, should address all the overcrowding needs that currently exist in Passaic.

A new Trenton Central High School, which the community has sought for more than a decade, is becoming a reality. The old high school is being demolished and, in its place, a state-of-the-art facility will be built to house all of the city's high school students from grades 10 to 12. Gloucester City, which has been advocating for a new middle school for years, will be welcoming 685 students in September 2017. Paterson and Jersey City will also be opening the doors of new schools which will educate students for generations to come.

While much of the focus of our work is on new and renovated buildings in SDA districts, we do much more. We do major emergent projects on legacy buildings to ensure that they continue to provide quality learning spaces for our children. We also administer grants throughout the entire state which permit regular operating districts to perform much-needed work on their schools. These are two programs that support education across the state.

We also look to level the playing field for small, minority and women-owned businesses. Each year we run a training program to assist small, minority and women-owned companies in navigating the maze of state regulations so that they will be in a better position to seek and obtain work with the Authority and throughout the state. We are proud of a program that continually gets good reviews from its participants.

So flip through the pages of this report and take in all of the great work that SDA is getting accomplished. There is plenty more to do, but we are effectively making a change in school facilities across the state.

SCHOOL CONSTRUCTION STATEWIDE

New School First of Three Phases to Address Overcrowding



In September 2015, 785 students started a new chapter in their education at the newly constructed Passaic Gifted and Talented Academy (PGTA). Completion of the new school also marked the completion of the first of three phases toward alleviating the overcrowding that exists in Passaic. Over the next six years, the SDA will deliver two more projects to Passaic, including one just across the street. Once completed, these projects will provide seats for a total of over 4,000 students and go a long way to addressing this community's needs.

Walking down the student-lined hallway filled with cheers and excitement, Lieutenant Governor Kim Guadagno joined SDA, district and local officials for a ribbon cutting ceremony to mark the school's opening on September 30.

This project had a complicated and lengthy history that predated the Christie Administration. However, once many of the current Administration's reforms were enacted, change orders were minimal and the school was delivered on schedule.

The PGTA represents the careful consideration that goes into the design of a new facility: the school's exterior design bears a contextual relationship to the surrounding residential dwellings, suitably assimilating into its neighborhood near the city's vibrant downtown area.



In this \$55 million, twenty-first century school, the focus is on providing Passaic students with an opportunity to excel in academics, performing arts, physical education, and visual arts. With these programmatic goals in mind, the school includes multiple science demonstration labs and even a flexible lab to provide for additional science instruction space, if needed. There is an art room with a kiln, instrumental and vocal rooms and a dance studio.

Realizing a Long-Awaited Vision



Multiple agencies contributed time and resources to the new Gloucester City Middle School project, in order to ensure that the site was appropriate and ready for a school. While the start of construction of this project had been long-awaited, it was the Christie Administration that finally made it happen. The groundbreaking held in May 2015 was a major step in bringing this important new school to fruition.

At a groundbreaking ceremony, Lieutenant Governor Kim Guadagno remarked that the Administration was keeping its promise to students and families in Gloucester City by providing the best possible learning opportunities to succeed.

The new \$63.9 million, 122,000-square-foot school is designed to educate approximately 685 students in the fourth through eighth grades. Utilizing the SDA's design-build approach, construction of the Gloucester City Middle School project made significant progress from the groundbreaking in May through the end of the reporting period. In fact, much of the steel was erected, allowing the community to visualize what their new school will look like.

A New High School for New Jersey's Capital City Takes Shape

The new Trenton Central High School project is a prime example of the productive results that come from a successful collaboration among stakeholders. Together with the Trenton School District, community residents, and the New Jersey Department of Education, the SDA has made great progress on the new school.

Since the Christie Administration advanced the new school project, the SDA has actively encouraged stakeholder and community input into the design of the school. As previously reported, the SDA hosted a design workshop for future students of the new High School, aimed at getting the students' perspectives on what the new Trenton Central High School should look like. The students' work was presented at a meeting

of the Trenton Board of Education, and helped to inform the work of the SDA Design Studio. During the current reporting period, the SDA presented three different design concepts to the School District and community members for their consideration during multiple school board and community meetings. The District then gathered community members' opinions by conducting online polling and establishing a dedicated email address. The District also polled students and teachers throughout May and June. At the conclusion of these efforts, the Trenton School Board passed a resolution in June selecting the third design option, which has come to be known as the "tornado design," a nod to the school's mascot.



Since that time, the SDA has moved forward with the design of bridging documents which were used to advertise for design-build services on September 29, 2015. The abatement and demolition of the old facility, which commenced in April 2015, continues and is expected to be completed by Spring 2016. The new Trenton Central High School will be a 350,000 square-foot school designed to educate 1,850 students in grades 10 through 12.

The New Jersey Schools Development Authority is currently managing a multi-billion dollar portfolio of school facilities projects across the state. At the end of this reporting period, there were twelve projects in

construction and dozens more are anticipated to be ready for construction within the next few years. A total 40 projects have been designated as part of the SDA Capital Portfolio since the start of the Christie Administration. At the end of the reporting period, the current status is:

- 4 projects are complete;
- 12 projects are in active building construction;
- 1 project has initiated Design-Build activities;
- 4 projects are in Design-Build procurement;
- 1 project is in Design-Build procurement and has ongoing site work activity;
- 1 project is in construction procurement;
- 1 project is in early site package procurement;
- 5 projects have design in progress
- 7 projects are in design development; and
- 4 projects are in scope development.

Noteworthy advancement on projects during the reporting period includes:

Construction Notices to Proceed (NTP) Issued

• The new **Gloucester City Middle School** (Camden County) will provide a 122,000 square foot school designed to educate 685 students in grades four through eight. The anticipated school opening is September 2017.

Early Site Preparation Activities

• Demolition of the existing building for the new **Trenton Central High School** (Mercer County) began in April 2015.

Projects that Initiated Early Site Work or Design-Build Procurement

- Early Site Work (Demolition) for the new **Madison Avenue Elementary School in Irvington** (Essex County)
- Design-Build Services for the new **Leonard Place Elementary School in Passaic City** (Passaic County)

- Design-Build Services for the new **Vineland Middle School in Vineland** (Cumberland County)

Buckshutem Road Elementary School







This addition and renovation design-build project includes a new gymnasium and classrooms, conversion of spaces to a new media center and a student services center. Student capacity will increase from 404 students to 580 students in grades K-8. During the reporting period, exterior brick facade and roof installation work was completed. Interior work, including drywall installation, mechanical, electrical and plumbing rough -in was ongoing. The addition is scheduled to open to students in January 2016.

Quarter Mile Lane Elementary School







This addition and renovation design-build project includes a new gymnasium, multi-purpose room, cafeteria and classrooms. Renovations will be made to existing classrooms and a new media center will be provided. Student capacity will increase from 254 students in grades K-8 to 730 students in grades Pre-K to 8. During the reporting period, interior work included mechanical, electrical and plumbing rough-in. Exterior work included roofing and masonry. The addition is scheduled to open to students in September 2016.

Elizabeth Academic High School

The new 183,000 square-foot, four-story facility, designed to educate nearly 1,100 students in grades 9-12 is being constructed on a site adjacent to the existing Thomas Jefferson Arts Academy. During the reporting period, work to fully enclose the building was ongoing. In addition, all major trade work continued in the building interior. The school is scheduled to open to students in September 2016.









Gloucester City Middle School

The 122,000 square-foot new designed to school is educate approximately 685 students grades 4 through 8. During the period, this reporting project broke ground and underground utility, footings and foundation installation work was completed. Structural steel erection commenced. This school scheduled to open to students in September 2016.

JERSEY CITY

Public School Number 20

The new 108,800 square-foot, three-story school is designed to educate approximately 620 students in grades K to 5. During the reporting period, work to enclose the building was completed and interior work was ongoing. The school is scheduled to open to students in September 2016.









Elementary School Number 3

The new 123,000 square-foot school will educate approximately 770 students in grades Pre-K to 5. During the reporting period, footings and foundation work continued and structural steel erection commenced. The school is scheduled to open to students in September 2017.



Keansburg Joseph C. Caruso Elementary School

The new 122,000 square-foot school will educate approximately 750 students in grades kindergarten through four. The new facility is being constructed on the site of the original 58,000 square-foot school. During the reporting period, steel erection was completed and a beam signing ceremony was held. In addition, slab on metal decking, masonry and roof installation work were ongoing. The school is scheduled to open to students in September 2016.







NEWARK

Elliott Street Elementary School

Located in the North Ward, the new 138,000 square-foot Elliott Street Elementary School is being built on the site of the former school, which was demolished following fire damage caused by a lightning strike. The new school is designed to educate 850 students in grades Pre-K to 8. During the reporting period, work on the exterior masonry veneer, interior masonry work, drywall work and window installation were ongoing. The school is scheduled to open to students in January 2016.









Oliver Street Elementary School

Located in the East Ward, the new Oliver Street 137,000 square-foot Elementary School is designed educate 850 students in grades Pre-K to 8. During the reporting period, interior and exterior masonry work and roof installation work were / ongoing. Sidewalks, curb and site grading activity is underway were ongoing. The school is scheduled to open to students Spring 2016.

PATERSON









The new 109,500 square-foot, threefacility will story educate approximately 700 students grades Pre-kindergarten through eight. During the reporting period, steel erection was completed, a beam signing ceremony was held, exterior masonry work ongoing and mechanical, electrical and plumbing work was ongoing. The school is scheduled to open to students in September 2016.







Marshall Street E.S.

The new nearly 109,000 square-foot school is designed to educate approximately 650 students in grades K to 8. During the reporting period, work to fully enclose the building was ongoing and interior work commenced. A pedestrian bridge over the NJ Transit track was also erected. The school is scheduled to open to students in September 2016.

Phillipsburg High School





The new 330,000 square-foot school is designed to accommodate approximately 1,840 students in grades nine through twelve. During the reporting period building envelope work proceeded. Masonry work was ongoing in exterior and interior areas. Mechanical, electrical and plumbing work continued throughout the building. The school is scheduled to open to students in September 2016.







Emergent Projects Replace Roofs and HVAC Systems on Aging Schools

Funding provided by SDA's Emergent Project Program makes possible important repair projects at aging schools throughout the state. Emergent projects are those deemed necessary by the state Department of Education in SDA Districts due to potential health and safety issues. These conditions in schools exist for various reasons.

Despite the diligent and proper maintenance efforts of the Vineland School District over many years, aging systems at the Vineland High



School required attention. In July, SDA CEO Charles McKenna was joined by Assemblymen Fiocchi and Andrzejczak, Mayor Bermudez and District officials to tour the \$11.4 million emergent project at the Vineland High School. This emergent project will provide a hot water-based HVAC system that will be more efficient, provide proper heat and improve the overall air quality for students.



The work at the high school includes the removal of three steam boilers and associated piping, pumps and equipment, the installation of a new hot water distribution system including boilers, water source heat pumps and associated equipment, and the installation of a pneumatic control system and building management system. This work would also allow the district to install air conditioning at a later date at its own cost should it choose to do so.

In August, Mr. McKenna visited the northern part of the state to tour an emergent project at Irvington High School with Senator Rice, Assemblywoman Tucker, Mayor Vauss and District officials. The \$6.5 million emergent project is providing roof replacement, masonry repairs and replacement of roof top HVAC units. The work also includes the replacement of direct digital control systems for the Annex and Library.





One of the most recurrent problems SDA confronts in aging buildings is water infiltration. On the tour of the Irvington emergent project, officials ventured onto the roof to see firsthand the type of work being done to ensure students can learn in facilities without concerns such as leaking roofs.

These projects provide examples of the significant facility work that is undertaken through the SDA's emergent project program. Emergent projects require careful planning, design, and in many cases, phasing of the work to minimize any disruption to the students' learning. Remedial projects at these two schools, more than 200,000 square feet each, represent huge undertakings.

Work like this is ongoing at schools throughout the state. At the end of the reporting period, the SDA was managing 11 emergent projects at 9 schools:


- 7 projects were in construction;
- 3 projects were in design; and
- 1 project was in design procurement.

Grants Benefit Regular Operating Districts Statewide

SDA Regular Operating District (ROD) grants fund at least 40 percent of eligible costs for projects in the New Jersey's ROD districts, addressing health and safety issues, and other critical needs. With an active ROD Grant portfolio of more than \$604 million in state share, the positive impact of the SDA's ROD Grant program on school facilities across the state is clear. From April 1, 2015 to September 30, 2015, the SDA executed 267 grants from Allocation Four (announced in December 2013) to 78 school districts for school improvement projects. This \$107.4 million state investment leverages a local contribution of \$125.3 million.

From the start of the Christie Administration in January 2010 through the end of the reporting period on September 30, 2015, the SDA has executed a total of 2,226 grants in 391 school districts statewide.



Spotlight on Salvage

Whenever SDA must demolish a building in order to provide a site for a new school, the contract with the demolition contractor includes salvage rights. This was the case with the abatement/demolition of the former Trenton Central High School facility. Prior to bidding the demolition/abatement contract, the SDA identified items to be salvaged by the SDA and District for reuse in the new school. Many items were saved from the former school including the weathervane, exterior lamps, one column capital and base, travertine wall veneer, and four mosaic panels, among other items. These items will be incorporated into the new building to allow future generations of Trenton Central High School students to recognize the past.

This school also sparked the interest of a national television show, "Salvage Dawgs." As a result, negotiations were held between the show's production company and the demolition contractor already contracted by the SDA. After finalizing negotiations in April, the "Salvage Dawgs" television show chronicled Black Dog Salvage's efforts to salvage items that neither the Trenton Board of Education nor the demolition contractor wanted or could salvage themselves. This provided a way to salvage additional materials from Trenton Central High School.

The salvage done by SDA, the school district, Black Dog Salvage and the awarded contractor/subcontractor will help to ensure that pieces of the original TCHS building continue to be used for many years to come, rather than end up in a landfill.



SUPPORTING SMALL BUSINESSES

Training Program Continues to Benefit New Jersey Firms

The SDA's fifth annual Small Minority and Women-owned Business Enterprise (SMWBE) Contractor Training Program concluded in April 2015. The 16 firms successfully completing the program were able to receive instruction on various topics that would help their companies grow and do business with the SDA. Classes were held at locations in both Trenton and Newark. As in previous years, following the nine-week seminar, a networking graduation event was held to provide graduates with an opportunity to meet face-to-face with many of New Jersey's large construction-related firms.

The training program strives to provide businesses with additional knowledge of SDA's program and processes that will enable firms to participate on various projects and work

throughout the state. SDA is committed to supporting the growth and success of small businesses in New Jersey and the SMWBE Contractor Training Program is one way in which we strive to do this.

Since the program was established, more than 80 firms have successfully completed the training program. Participants have consistently been pleased with the information and networking opportunities provided to them through the program.



Construction Contracts for Small Businesses

In December 2010, the Governor signed legislation that directs the SDA to biannually compile information on the number of school construction contracts entered into between the Authority and minority and women contractors during the reporting period. This information must include the total value of these contracts and the percentage that they represent of all school facilities project construction contracts entered into by the Authority.

The SDA's SBE program goal is to ensure that 25% of the total dollar value of all publicly advertised contracts awarded by the SDA during a fiscal year goes to Small Business Enterprises (SBE). The SDA requires consultants and prime contractors to make good-faith efforts to identify available SBE subconsultants and SBE subcontractors and award at least 25% of the total contract value to them. The SDA consistently exceeds this goal, as evidenced by the nearly 45% of awards that went to SBEs during this reporting period.

During the reporting period, SBE/minority-owned businesses were awarded \$1,237,351 or 1.79% of SDA total construction contracts awarded. Also, SBE/women-owned businesses were awarded \$3,562,589 or 5.14% of SDA total construction contracts awarded.

In addition, although not required to do so, SDA has started to track and collect Veteran Owned Business (VOB) opportunities data. During the reporting period, Small Business Veteran Owned Businesses received \$999,000 or 1.44% of SDA total construction contracts awarded.

SDA FINANCES

Financial Overview

In total, the New Jersey State Legislature has authorized \$12.5 billion in funding for the SDA (\$8.9 billion for SDA Districts, \$3.45 billion for RODs and \$150 million for vocational schools). Since the program's inception, the amount of bonds issued to date to fund the program is \$10.109 billion. As reflected in Appendix F, there was a \$500 million bond issuance during the reporting period.

Bonding activity supports the entirety of the SDA's portfolio and is not tied to individual projects. Generally, the timing for such bonding activity coincides with projected cash flow requirements for already-committed projects in the SDA's portfolio. This ensures that the SDA has the necessary cash available to pay its vendors as projects progress.

SDA currently has approximately \$739.2 million in cash on hand, having disbursed \$232.2 million during the reporting period. The 2014 financial statements, audited by Ernst & Young LLP, were approved by the SDA Board in April 2015 and can be found on the SDA's website at http://www.njsda.gov/RP/reports/SDA_Financial_Statement_14.pdf.

Fiscal Efficiency

The SDA is committed to safeguarding the limited resources that have been allocated by New Jersey taxpayers to fund school construction projects throughout the state. Therefore, under the Christie Administration, the SDA has continued to scrutinize past and present projects to determine if there are any opportunities to recover funds to enable advancement of future SDA projects.

During the reporting period, SDA was successful in its cost recovery efforts. In August 2015, the SDA recovered \$177,128 for environmental remediation costs incurred in connection with the Newark Park Elementary School Project. In September 2015, the SDA settled cost recovery litigation against the project management firm, design consultant and environmental sub-consultant on the Trenton Martin Luther King, Jr. Elementary School Project, receiving a combined settlement payment of \$2,725,000. The Authority has also received the final payment of \$46,313 in a series of payments under a consent judgment entered against a consultant vendor on the East Orange Langston Hughes Elementary School Project.

In addition, between April 1, 2015 and September 30, 2015, the SDA resolved \$1,782,093 in contractor claims for a total settlement amount of \$1,150,217. These settlements equal roughly 65% of the original amounts claimed and represent a cost avoidance to the SDA of \$631,875.
