For clarification purposes, NJSDA submits the following to further clarify NJSDA's answer to Question A.1 from Addendum No. 2. Question A.1 and NJSDA's answer is restated in its entirety below. New clarification is identified in ***bold italics***:

A.1 QUESTION: Will the NJSDA accept the "Electronic Board Books" solution provider's standard legal and commercial terms and conditions as a starting point for negotiations and the basis for the final agreement?


A.1 ANSWER: NJSDA is willing to consider additional terms and conditions which are not incompatible with the Terms and Conditions set forth in Attachment C to the RFP. Firms interested in such additional terms and conditions are required to submit their requests in writing, in the form of an RFI, on or before ***July 30, 2012***. NJSDA will respond to the RFI prior to the revised date for submission of the Technical Proposals and Fee Proposals.

Firms wishing to submit Technical Proposals and Fee Proposals must agree to comply with all relevant Contract provisions, including the Scope of Services set forth in Attachment A, and the Terms and Conditions set forth in Attachment C. No additional Terms and Conditions which conflict with the RFP will be considered. Proposed additional Terms and Conditions will not be considered if they are not raised in a timely RFI.

Potential bidders should be aware that any proposed additional contract terms and conditions may not be kept confidential. Bidders are requested to submit proposed additional contract terms for review on or before July 30, 2012, however, these terms will be treated as RFI's and disclosed to all bidders in a subsequent Addendum, along with NJSDA's response to each of the proposed terms.
