Eight Week Seminar Provides Small, Minority and Women-Owned Business Enterprises with Tools and Knowledge on How to Do Business with Schools Development Authority

To date, 45 firms have successfully completed the SDA's SWMBE Contractor Training Program. Previous graduates of the program have become prequalified with the State to do business, have obtained government contracts and increased their professional network.

Participating firms have consistently expressed overwhelming satisfaction with the program and in its ability to help them grow and improve their business.
