

## **CEO MESSAGE**



The period from April 1 through September 30 was marked by building at a frenzied pace in order to complete seven projects. This was followed by a feeling of incredible satisfaction upon the opening of seven schools where children across the state will be educated in state-of-the-art-learning facilities. We opened two new schools in Paterson, one in Keansburg, one in Jersey City, and a new addition in Bridgeton along with high schools in Elizabeth and Phillipsburg. With the opening of those buildings, as well as two schools in Newark that opened earlier in the year, the SDA has provided more than 8,500 new seats where children will be learning. In addition, Paterson students who formerly attended the run-down Don Bosco School

started this school year in the former Paterson Catholic High School, which was purchased and upgraded by SDA for their use.

As the leader of this fine organization, there was no better feeling than seeing the smiles on the faces of children in their new schools. It signaled to them and their parents that this State and the Christie Administration care about their futures and are willing to support it with new facilities to advance their education.

None of this work would be possible without the incredible efforts of the entire SDA staff -- from the facilities people who make our working environment sound, to the records people who are now digitizing all of our files, to the legal and accounting, financial and internal auditing staffs who keep us on the straight and narrow. Our procurement department ensures fairness and fiscal responsibility in our engagement of all the services we use and our insurance people make sure that we are protected. Our IT staff keeps our information systems humming along, our grants staffs ensures that the entire State gets educational upgrades, our special projects folks handle out of the ordinary tasks such as our SWMBE training, our real estate people manage our properties and acquisitions, our corporate relations folks ensure that our Board is given all that it needs to guide us and our communications staff touts us both inside and outside the organization. Finally, our planning, and design folks take the projects from the idea phase and turn them into working documents that our construction operations folks turn into the fine buildings that we turn over to school districts in completely furnished fashion. We do this all while maintaining our safety standards thanks to our folks who check on the working conditions at all of our jobs and properties. This is a great organization that I have the honor of leading and together we make things happen for the children of this State.

## **BUILDING SCHOOLS, BUILDING COMMUNITIES**

### **Revamped SDA Program Delivers Results**

With September school openings, 2016 has been a year in which more than 8,500 students had access to seats in new or renovated learning centers throughout the State. The successful delivery of school facilities, specifically during this reporting period, exemplifies the achievement of the responsible and accountable school construction program implemented under the Christie Administration.

During the reporting period, SDA held eight ceremonial ribbon cuttings in seven School Districts, highlighting the positive impact that the State's investment and the work of the SDA has had on these communities. The smiles on students' faces reflected their excitement with their new state of the art learning spaces.

All of the schools that opened in 2016 were designed incorporating the guidelines developed by the United States Green Building Council (USGBC) known as the "Leadership in Energy & Environmental Design ("LEED®") program in order to achieve maximum energy efficiency and environmental sustainability in the design of schools. The new schools will be submitted for LEED certification, including a couple schools expected to achieve Silver or Gold designations. In addition, all of the new schools were built utilizing the materials and systems standards that were instituted by the SDA in 2011.

Programmatic reforms instituted at SDA are having the intended result of ensuring predictability, minimizing surprise and keeping commitments, as evidenced by the fact that the schools opened this year were completed on or ahead of schedule and all were on budget. Through the use of the design-build approach and an enhanced constructability review process for design-bid-build projects, SDA's new schools experienced far fewer change orders than in prior periods. In fact, the design-build or construction contracts for schools that opened in 2016 experienced an average of less than four percent in change orders. In comparison, from 2002 to 2009, construction contracts for completed projects experienced an average of nearly 17 percent in change orders.

The end result is educational learning centers that not only benefit the students who have the opportunity to learn within their walls, but also positively impact their surrounding communities, all delivered with a commitment to fiscal responsibility.



### Shovels in the Ground

On a sweltering day in September, taking a break from school opening celebrations throughout the State, the SDA broke ground for a new South Street Elementary School in Newark. This is the third new school to be built by the SDA in Newark during the Christie Administration.

The new South Street Elementary School will be an approximately 103,000-square-foot facility



designed to accommodate 657 students in grades Pre-kindergarten through eight. The project includes a separate parking area adjacent to the new facility. Once complete, the school will include 29 general classrooms, two science labs, six small group instruction rooms, a computer/technology lab, a world languages classroom, instrumental and vocal music rooms, an art room, a media center, a multipurpose room with stage, a cafeteria and a gymnasium.

Early construction activities also began on several other projects during the reporting period. Among this important early phase work were abatement activities for both the addition/renovation project at the Robeson Community School for the Arts in New Brunswick and for the rehabilitation of West New York Harry L. Bain Elementary School, as well as site clearing activities for the new Lincoln Avenue Middle School in Vineland and site preparation work for the new Trenton Central High School. Formal groundbreaking ceremonies will be scheduled prior to the end of the year to celebrate the start of some of these projects.

### **Preparing Sites for Schools**



Reforms instituted under the Christie Administration included completion of demolition and preliminary site preparation activities prior to advancing the construction of a school project, whenever appropriate. Doing so helps to maximize project predictability by minimizing or eliminating site issues that could impact the schedule and costs associated with the construction of a new building. The SDA has enjoyed significant success with this process, as evidenced by a substantial reduction in unforeseen

issues, schedule delays and change orders related specifically to the condition of project sites.

Early site preparation activities were initiated on several projects during the reporting period. In Irvington, the SDA demolished the original Madison Avenue School to make way for the new facility. SDA staff joined Irvington School District officials to witness the building's demolition. During the first days of the demolition, the SDA's contractor uncovered a time capsule that was found in the annex

section of the building. The contents, still intact, included various papers including a newspaper published in 1958, the year the annex was built.

At a school site in East Orange, abatement work on the original George Washington Carver Elementary School commenced to ready the building for demolition. In Harrison, work began to prepare the site for a new Pre-K to first grade elementary school.



### **Open Communication with Impacted Communities**

SDA remains committed to engaging with communities that will be impacted throughout the duration of a construction project. The SDA strives to provide information to residents living in the vicinity of a school construction project regarding what they can expect and we remain available to respond to any concerns they may have. Shared information often includes permissible work hours (as governed by local building codes), anticipated project timelines, the type of work that will occur and contact information should any future questions arise.

During this reporting period, SDA staff attended community meetings in East Orange, Harrison, New Brunswick, Vineland and West New York as part of this outreach effort. The SDA considers these meetings as an important opportunity to initiate communication with the community members through an open dialogue forum where they can get answers to their questions and concerns.

### **Capital Portfolio Project Advancement**

The work of the Authority makes a real difference in the lives of thousands of students across the state. Projects being built now will, once completed, serve more than 6,500 students for many years to come. With ten projects in active construction at the end of the reporting period, and many more in various stages of advancement, the work of the SDA is helping to strengthen communities. The ten projects in construction, representing more than \$487 million in total costs, will significantly reduce the overcrowding that exists in these school districts.

Since the start of the Christie Administration, 40 projects were approved as part of the SDA Capital Portfolio. At the end of the reporting period:

- 13 projects were complete;
- 10 projects were in active building construction;
- 2 projects initiated the design phase of the design-build procurement;
- 3 projects are in design-build procurement;
- 8 projects are in design development (SDA Design Studio/Bridging architect);
- 2 projects are in pre-design (Design consultant); and
- 2 projects are in planning and scope development.

Noteworthy advancements on projects during the reporting period include:

Design-Build Projects Notices to Proceed (NTP) Issued

- The New **Trenton Central High School** (Mercer County) will be a 350,000 square-foot school designed to educate 1,850 students in grades 10 through 12. The anticipated school opening is September 2019. The NTP for design was issued in April.
- The new **Seaman Avenue Elementary School** in Perth Amboy (Middlesex County) will be a 120,000 square-foot school designed to educate approximately 700 students in grades

kindergarten to fifth. The anticipated school opening is September 2019. The NTP for design was issued in August.

Construction Notice to Proceed Issued

• The new **James Madison Elementary School** in Garfield (Bergen County) will be a 53,000 square-foot, three-story school designed to educate approximately 275 students in grades kindergarten through 5. The anticipated opening is September 2018. The NTP was issued in May.

Early Site Preparation Notices to Proceed Issued

• A NTP was issued in August for early site preparation activities associated with the new **George Washington Carver Elementary School** in East Orange (Essex County).

Projects that Initiated Early Site Work, Construction or Design-Build Procurement

- A Design-Build procurement for the Millville Senior High School (Cumberland County).
- A Design-Build procurement for the new Madison Avenue Elementary School in Irvington (Essex County).

### An Aging Educational Infrastructure in New Jersey

The SDA's Emergent Project Program helps to address many of the facility concerns that arise as a result of many SDA District's aging educational infrastructure. Since the start of the Christie Administration, 145 emergent projects have been completed in 27 SDA Districts.

Currently, the SDA is managing six emergent projects with two in construction and four more in the design phase. During the reporting period, the substantial completion of several large projects was achieved. This includes a large roofing/HVAC project in Irvington and the replacement of an aging HVAC system in Vineland.

Local school districts also continued working on another 24 projects that previously were delegated to the Districts for management. This includes 14 projects in construction and 10 in design at schools in six SDA Districts.

The SDA recognizes the need to identify and address additional emergent conditions that exist throughout the SDA Districts. Therefore, the SDA and the New Jersey Department of Education recently initiated efforts to identify potential emergent conditions to be addressed with the remaining funds allocated for the Emergent Program. The primary focus of this effort is to address water infiltration issues

specifically as these conditions can be severely damaging to buildings, often causing a "domino" effect of facility issues throughout a school.

## Grants

SDAs Regular Operating District (ROD) Grant program funds at least 40 percent of eligible costs for approved projects in New Jersey's ROD districts, addressing health and safety issues, and other critical needs. The Christie Administration's commitment to support critical school improvement projects in New Jersey through this program is another important step to addressing the State's aging education infrastructure.

With an active ROD Grant portfolio of more than \$530 million in state share, the SDA's ROD Grant program continues to have a positive impact on school districts across the State. From April 1, 2016 to September 30, 2016, the SDA executed 107 grants to 32 school districts for school improvement projects. This \$30.8 million state investment leverages a local contribution of \$36.9 million.

From the start of the Christie Administration in January 2010 through the end of the reporting period on September 30, 2016 the SDA has executed a total of 2,129 grants in school districts statewide.

SDA ROD Grants executed during this reporting period include projects such as:

- Elsinboro Township School District Elsinboro Elementary School (Salem County): Exterior door replacement, HVAC, boiler, security upgrades. State share: \$490,343; Estimated total project costs: \$1,225,858.
- Piscataway Township School District Piscataway Township High School (Middlesex County): Bathroom ADA renovations. State share \$662,200; Estimated total project costs: \$1,655,500.
- Roselle Borough School District Abraham Clark High School (Union County): New HVAC, associated piping and electrical upgrades. State share: \$1,805,881; Estimated total project costs: \$3,041,351.
- Roxbury Township School District Roxbury High School (Morris County): Roof replacement at two-story section. State share: \$776,000; Estimated total project costs: \$1,940,000.
- Sterling High School District Sterling High School (Camden County): Site Work, Exterior Closure, Electrical, Plumbing, HVAC, Communications. State share: \$3,568,548; Estimated total project costs: \$5,771,875

## ASSISTING BUSINESSES

## **SDA's In-House SMWBE Training Program Evolves**

In May 2016, the SDA's sixth installment of the annual Small Minority and Women-owned Business Enterprise (SMWBE) Contractor Training Program culminated with a graduation/networking event, which recognized the 25 participant firms who successfully completed the program.

This year several changes to format and content were implemented enabling the program to benefit newer start-up companies. The revised program, which offered six weeks of instructional classes followed by a graduation/networking event, commenced in March 2016 with classes held at locations in both Trenton and Newark. This year, the program provided participants with information on business plan development, Prevailing Wage, and navigating SDA and State websites.

In addition, following the conclusion of the formal training program, several advanced courses were offered to recent and past program graduates. This included a seminar this summer focused on Prevailing Wage requirements which offered participants insight from a representative of the Department of Labor. In the fall, a finance forum was held to assist companies in finding the funding they need to grow.

The SDA's SMWBE Contractor Training Program continues to be a valued resource to New Jersey's small businesses interested in growing their companies and potentially working with the State. SDA plans to continue the full training program in 2017 and host additional seminars as needed.



## **SDA Benefits SBE's**

In December 2010, the Governor signed legislation directing the SDA to biannually compile information on the number of school construction contracts entered into by the Authority with minority and women contractors. This information must include the total value of these contracts and the percentage that they represent of all school facilities project construction contracts entered into by the Authority during the reporting period.

The SDA's SBE program goal seeks to ensure that at least 25% of the total dollar value of all publicly advertised contracts awarded by the SDA during a fiscal year goes to Small Business Enterprises (SBE). The SDA requires consultants and prime contractors to make good-faith efforts to identify and

hire available SBE sub-consultants and SBE subcontractors and to award at least 25% of the total contract value to them. The SDA consistently meets or exceeds this goal as represented in the 49.88% achieved this reporting period.

The total SDA Construction Contracts figure listed in the chart above does not include the total value of Design-Build contracts awarded during the reporting period of \$43,570,000 for the new Seaman Avenue Elementary School in Perth Amboy and \$115,950,000 for the new Trenton Central High School. Since these projects were still in their design phase during the reporting period, and SBE contracts are not captured until the construction phase begins, the full value of these projects will be included in future construction contract totals.

During the reporting period, SBE/minority-owned businesses were awarded \$3,829,668 or 11.23% of total construction contracts awarded by the Authority. Also, SBE/women-owned businesses were awarded \$24,250 or 0.72% of SDA total construction contracts awarded.

## **Bidding SDA Projects – An Online Seminar**

The SDA's robust construction portfolio presents many opportunities for construction-related firms to seek work with the State's school construction program. However, in order to compete, firms must ensure that they submit responsive bids.

This summer, the SDA launched an SDA Online Seminar - "Responsive Bidding: The Do's and Don'ts of Bidding SDA Design-Build Projects. This 20-minute presentation is narrated by Jane Kelly, SDA Vice President of Corporate Governance and Operations and Andrew Yosha, Executive Vice President of Program Operations and Strategic



Planning. It provides firms with tips for avoiding making the common mistakes and/or omissions that often lead to a bid package being deemed unresponsive. This new section of the SDA's website also provides helpful checklists that can be printed for use when preparing a bid package.

## FINANCIAL OVERVIEW

In total, the New Jersey State Legislature has authorized \$12.5 billion in funding for SDA projects (\$8.9 billion for SDA Districts, \$3.45 billion for RODs and \$150 million for vocational schools). Since the program's inception, the amount of bonds issued to fund the program is \$10.1 billion, including \$2.16 billion since 2010. There were no new bonds issued during the reporting period.

As of September 30, 2016, SDA had approximately \$315.0 million in cash on hand, having disbursed \$209.7 million during the reporting period (April 1, 2016 – September 30, 2016). The 2015 financial statements, audited by Ernst & Young LLP, were approved by the SDA Board in June 2015 and can be found on the SDA's website at:

The SDA strives to safeguard the resources that have been afforded to the program. Toward that goal, SDA pursued several cost recovery cases and anticipates reaching settlement for these cases in upcoming reporting periods.

In addition, between April 1, 2016 and September 30, 2016, the SDA resolved \$555,041 in contract claims for a total settlement amount of \$116,369. These settlements equal roughly 21% of the original amounts claimed and represent a cost avoidance to the SDA of \$438,672.

The table above provides a comparison of cost per square-foot for new school construction (public schools) in both the Philadelphia and New York City Metropolitan Statistical Comparison (MSAs). This addresses the August 2007 statutory requirement that costs of school facilities projects undertaken and funded by the SDA be compared to similar school facilities projects constructed in the New York City and Philadelphia MSAs.

The U.S. Office of Management and Budget is responsible for developing standards for defining MSAs and for applying these standards with Census data.

The table above also includes information from the School Planning and Management School Construction Report, a recognized national-construction data source, as well as information from the New York City Department of Education School Construction Authority. The use of multiple sources to monitor and analyze construction costs provides assurance that industry-wide pricing trends are addressed.
