OR

Underground Storage Tanks/Closure C115

OR

Construction Contractor with a DPMC Classification of C008 or C009 who will be required to also have the following DPMC Specialty Trade(s) or required to engage a subcontractor classified in the following DPMC Specialty Trade(s) if not possessed by the Construction Contractor:

Site Remediation: C119

AND

Underground Storage Tanks/Closure & Installation C113

OR

Underground Storage Tanks/Closure C115

OR

Demolition Contractor with a DPMC Classification of C021 who will be required to also have the following DPMC Specialty Trade(s) or required to engage a subcontractor classified in the following DPMC Specialty Trade(s) if not possessed by the Demolition Contractor:

Site Remediation: C119

AND

Underground Storage Tanks/Closure & Installation C113

OR

Underground Storage Tanks/Closure C115
