D. BIDDER'S QUESTIONS, REQUESTS FOR INFORMATION AND RESPONSES:

1. Question: The Project Schedule on page 2 of the CM RFP "Attachment B", indicates: "Final Completion / Contract Completion" (... is...) 3/13/2017 (based on a 1,063 day duration for achievement ... measured from D-B Commencement Date")

If the 1,063 day duration is correct, and the 7/19/2013 D-B Commencement is correct, then the Final Completion / Contract Completion Date should be sometime in June 2016, not March 2017. This would also indicate a [reasonable] 90-day Close-Out period.

Answer: Final Completion/Contract Completion should read **6/16/2016** not 3/13/2017 (based on 1,063-day duration for achievement of Final Completion and Contract Completion measured from D-B Commencement Date). See also Items B.1.a. and C.1.a. above for procurement process changes and contract modifications reflecting this change.
