## B. PREBID QUESTIONS & NJSDA ANSWERS

**B.1 Question:** Will utilities be relocated due to demolition and street closings? If so, does the CM's scope cover managing that process?

**Answer:** The Utilities will be relocated as part of the demolition package. This is not part of the CM Scope.

**B.2 Question:** What is the anticipated timeframe for the demolition phases? Will the CM monitor the demolition phase?

**Answer:** The demolition has an anticipated NTP date of November 24, 2009. Please refer to B.1 above.

**B.3** Question: Are there any geo-technical features associated with the project?

**Answer:** None at this time.

**B.4** Question: Is there a basement included in the project?

**Answer:** There is not a basement associated with this project.

**B.5 Question:** How far away is the potential hospital construction?

**Answer:** That information is unknown at this time. NJSDA is in constant contact with all parties to measure progress of this project.

**B.6 Question:** What are the anticipated dates for GC NTP, CM NTP and Substantial Completion?

**Answer:** Anticipated GC NTP date is June 1, 2010. Anticipated CM NTP date is November 10, 2009. Anticipated Substantial Completion date is June 30, 2012.

**B.7** Question: Will the CM position be required to be full time during pre-construction?

Answer: Yes.

**B.8** Question: Is the Remedial Action Work Plan (RAWP) available?
