**A. CHANGES TO THE PROCUREMENT PROCESS:**

**1. Modifications to Procurement Submission Dates and Deadlines:**

- a. **Mandatory Site Visit:** The date for the re-scheduled mandatory site visit is changed from February 19, 2015 to **March 3, 2015 at 10:00am (local time)** at the Irvington High School.
- b. **Extension of Due Date for Bidder Questions:** Eligible firms may submit questions regarding this procurement to the NJSDA by e-mailing such questions to Procurement Officer Alison Perry ([aperry@njsda.gov](mailto:aperry@njsda.gov)) no later than 1:00 PM (local time) on **March 5, 2015**.
- c. **Extension of Due Date for Bid Submissions:** The due date for submission of the Bid Proposals is changed from March 12, 2015 to **March 19, 2015 at 2:00pm** (local time).

**2. Modifications to the Advertisement**

- a. **MODIFY:** The first sentence of the sixth full paragraph of the Advertisement, beginning with “Bids will be received until” shall be modified as follows (deletions shown in *italics and strikethroughs*; additions shown in **bold and underline**):  
Bids will be received until ~~March 12, 2015~~ **March 19, 2015** at 2:00 PM (local time) at which time the bids will be publicly opened and the lump sum base bid price submitted by each bidder will be read.

- b. **MODIFY:** The ninth full paragraph of the Advertisement, beginning with “Immediately following the **Mandatory** pre-bid” shall be modified as follows (deletions shown in *italics and strikethroughs*; additions shown in **bold and underline**):

*Immediately following the Mandatory pre bid there will be a* **The Mandatory site visit is scheduled for March 3, 2015 at 10:00 am (local time) at the Irvington High School.**

**D. BIDDER’S QUESTIONS AND NJSDA RESPONSES:**

1. Question: Will a licensed asbestos subcontractor be required or will Roofing subcontractor be allowed to remove and properly dispose of asbestos containing materials?

**Answer: Refer to the Construction Drawing Sheet A1-00, General Roofing Notes, Note #19.**

2. Question: We respectfully request that the RFI Deadline of 2/24/2015 be extended at least 1 week. Tuesday 2/24/2015, is an unrealistic deadline in light of the fact that access to the Plans & Specs have still not been provided and we were not given an opportunity to walk the site yesterday. That deadline doesn’t provide an opportunity to review the plans & specs, distribute the plans & specs to subcontractors and suppliers and afford them and us any time to review and propose questions. It would be beneficial to all parties to extend the Period for questions.

**Answer: The Mandatory Pre-Bid Conference held on February 19, 2015 did not include the mandatory site visit due to snow and ice conditions. Eligible firms that attended the Mandatory Pre-Bid Conference were advised that the mandatory site visit would be re-scheduled. 
