1. **Question:** Is it acceptable to utilize Pro-Press Systems for hydronic piping 4" and smaller to reduce risk of fire and fumes during occupied hours?

Answer: Piping applications shall match Specification Section 232113 ("Hydronic Piping"), subsection 3.1 ("Piping Applications").

2. **Question:** Confirm abatement contractor is responsible for boiler demo.

Answer: The abatement contractor is responsible for removal of the asbestos from the boiler and its associated components. The remaining work associated with demolition of the boiler may be self- performed by the General Contractor, or at the option of the General Contractor, the remaining demolition work may be performed by the abatement contractor or another subcontractor, as it is within the General Contractor's discretion as to how to define the means and methods to best accomplish the Project work.

2. **Question:** In reviewing the specs for the project I noticed Tozour Energy was listed as the only acceptable vendor. We ran into a similar issue on the Bridgeton High project where a sole sourced vendor was listed. This was ultimately revised to accept others vendors based on the proprietary vendor state statute. Do you know if this project has attained a waiver from the State approving Tozour as a sole source provider of services for the ATC systems?

Answer: Yes, the district has secured a waiver from the State approving Tozour as a sole source provider.
