Interested firms must submit one unbound original, three (3) bound copies, and two (2) CDs containing full cover-to-cover PDF copies required of the Technical Proposals to the NJSDA for consideration. The Technical Proposals must be received by the NJSDA by **5:00 PM on ~~Tuesday, September 3, 2013~~ Wednesday, September 4, 2013**. Faxed or e-mailed Submittals shall not be accepted.



- b. **Revise:** The fourth paragraph of section 1.3 B of the RFP (“Price Proposal”), shall be revised as follows, to change the due date for submission of the Price Proposal to Wednesday, September 4, 2013 (additions in **bold and underlined** text; deletions in *strikethrough and italics*).

The Price Proposal must be sealed and submitted with the original Technical Proposal and received by the NJSDA by **5:00 PM** on ~~Tuesday, September 3, 2013~~ **Wednesday, September 4, 2013**. Faxed or e-mailed Price Proposals shall not be accepted.


