2. Technical Proposal

Interested firms must submit a Technical Proposal, which provides responses to the non-price "other factors" evaluative criteria requirements of this RFP. Interested firms must submit one unbound original, three (3) bound copies, and two (2) CDs containing full cover-to-cover PDF copies required of the Technical Proposals to the NJSDA for consideration. The Technical Proposals must be received by the NJSDA by 5:00 PM on *Wednesday*, *Oetober 2*, 2013 Tuesday, October 8, 2013. Faxed or e-mailed Submittals shall not be accepted.

D. BIDDER'S QUESTIONS AND NJSDA RESPONSES:

1. **Question:** Reference is made to Addendum #6, Bidder's Question #2 and the response provided regarding the Geotechnical Report contained within the bid documents. Specifically,

the conclusion provided in the Report is that spread footing foundations will be adequate to support the building's loads without excess settlement. Should the bidders base their foundation design on that conclusion?

If so, and after the project is awarded it is discovered that the foundation design must be enhanced, such as using piles, geopiers, etc., will the NJSDA issue a change order to cover the additional costs of the redesign?

The responses to these questions are very important in that all Design Teams are basing their bids on the same criteria and understanding of the NJSDA's position regarding the Design/Builder's obligation in respect to foundation design.

Answer: It is the responsibility of the Design-Builder to reach their own conclusions regarding the appropriate type of foundation system to be provided as part of their design and price proposal. The proposed design must be based upon a review of the geotechnical and other information provided in the Design-Build Information Package, as well as the requirements of the Design-Builder's specific design solution.
