1. Modification to Procurement Submission Dates and Deadlines:

2. Modifications to Bid Advertisement:

- a. **Revise:** Item D. under the Procurement Submission Dates and Deadlines of the Bid Advertisement, shall be revised as follows, to change the date for submission of the Technical Proposals, and Price Proposals to November 7, 2013 (additions in **bold and underlined** text; deletions in *strikethrough and italics*).

D. Interested firms must submit a Technical Proposal, which provides responses to the non-price "other factors" evaluative criteria requirements of the RFP. The Technical Proposals must be received by the NJSDA by **5:00 PM on ~~October 29, 2013~~ November 7, 2013**. Faxed or e-mailed submittals shall not be accepted.

Bidders must simultaneously submit a sealed Price Proposal which must be submitted with the Technical Proposal and received by the NJSDA by **5:00 PM on ~~October 29, 2013~~ November 7, 2013**. Faxed or e-mailed Price Proposals shall not be accepted. Any Technical or Price Proposals received after this date and time will be returned unopened.

- a. **REVISE:** Section 1.3 B.2 of the RFP ("Technical Proposal"), shall be revised as follows, to change the due date for submission of the Technical Proposal to **November 7, 2013** (additions in **bold and underlined** text; deletions in *strikethrough and italics*).

#### 2. Technical Proposal

Interested firms must submit a Technical Proposal, which provides responses to the non-price "other factors" evaluative criteria requirements of this RFP. Interested firms must submit one (1) unbound original, three (3) bound copies, and two (2) CDs containing full cover-to-cover PDF copies required of the Technical Proposals to the NJSDA for consideration. The Technical Proposals must be received by the NJSDA by **5:00 PM** on ~~Tuesday, October 29, 2013~~ **November 7, 2013**. Faxed or e-mailed Submittals shall not be accepted.

- b. **REVISE:** The fourth paragraph of section 1.3 B.3 of the RFP ("Price Proposal"), shall be revised as follows, to change the due date for submission of the Price Proposal to **November 7, 2013** (additions in **bold and underlined** text; deletions in *strikethrough and italics*).

The Price Proposal must be sealed and submitted with the original Technical Proposal and received by the NJSDA by **5:00 PM** on ~~Tuesday, October 29, 2013~~ **November 7, 2013**. Faxed or e-mailed Price Proposals shall not be accepted.
