DESCRIPTION: Addendum No. 1

This addendum shall be considered part of the Bid Documents issued in connection with the referenced project. Should information conflict with the Bid Documents, this Addendum shall supercede the relevant information in the Bid Documents.

A. CHANGES TO THE DRAWINGS:

1. REPLACE: Fence Location Plan C-3, dated August 13, 2014, is deleted and replaced with revised Fence Location Plan C-3, dated August 21, 2014, issued herewith as Attachment 1.1.

B. BIDDER'S QUESTIONS AND NJSDA RESPONSES:

1. **QUESTION:** Who will take care of the permits?
ANSWER: The SDA will submit for plan review. Once the plans are released by the DCA, the Contractor shall adhere to sections 3.5, 4.10, and 6.6 of the General Conditions.
2. **QUESTION:** Who will take care of pedestrian/ traffic control if any?
ANSWER: This is the responsibility of the Contractor, as identified in section 4.6 of the General Conditions.
3. **QUESTION:** Who will take care of the safety signage?
ANSWER: This is the responsibility of the Contractor, as identified in section 4.6 of the General Conditions.

4. **QUESTION:** Why do you need to use a 1” mesh (it is more expensive than using 2” both labor and material) and is it necessary?
ANSWER: The Contractor shall adhere to the plans and specifications as stated in section “4.0 Contractor’s Responsibilities” of the General Conditions.
5. **QUESTION:** Why do you have to use ASTM A 123 schedule 40, this refers to 2 oz steel (very expensive). Standard is 1.8 oz schedule 40 ASTM 1083/1043 (especially if you are going to remove this in a couple of years)?
ANSWER: The Contractor shall adhere to the plans and specifications as stated in section “4.0 Contractor’s Responsibilities” of the General Conditions.
6. **QUESTION:** Can our men use the toilets in the school or should we rent out Port Johns?
ANSWER: Contractor is required to provide toilets facilities during the construction period in accordance with the General Conditions section 6.18.2.
